## **Official of the Year**

Roy Kissack was a Field Official from Lincolnshire who was much loved by all of his peers, he so loved coming to Derby that he viewed it as his second home. Sadly Roy died in 2009. His family in his memory, because of his love of Derby donated a Memorial Shield to be presented to the Derbyshire Official of the Year.

The 2014 Derbyshire Official of the Year who received the Roy Kissack Memorial Shield, which was first presented in 2010, began officiating when his children competed for Chesterfield & District AC. His interest in the sport of shooting, lead him towards the role of Starter & Marksman.

This Official began with club athletics and still regularly officiates for Chesterfield AC, other club meetings in the county including the County Schools Championships and our County Championships.

He has risen through the ranks to International status culminating in being one of the Starters at the 2012 Olympic and Paralympic Games in London. His claim to fame there was that he started the Men's 200m Final which was won by that Jamaican legend, Usain Bolt.

He is also known to encourage and mentor less experienced Officials including many youngsters who show an interest in officiating.

Our President, Julie Feeney, had the great pleasure to present the Roy Kissack Memorial Shield for 2014 to Gordon Staines.

## **Disclosure & Barring Service (DBS) (formerly CRB)**

Recently some officials have had problems with DBS and the issue of Licenses so here is a little reminder of what you need to do, plus some useful information.

A few weeks before your License is due to expire Athletics Welfare in Sale will send you an application form for a DBS check. Complete the form and get all the necessary

documentation verified by an accredited verifier. (This can be Club president or Secretary, County Official's Secretary, Mike or Ernie, or the Officials portfolio holder Barry Parker) Send the completed DBS application form to Athletics Welfare having first made a note of the form number, this will enable you to track your application on the DBS web site <a href="https://secure.crbonline.gov.uk/enquiry/enquirySearch.do">https://secure.crbonline.gov.uk/enquiry/enquirySearch.do</a>

When you receive your Disclosure from the DBS

**YOU MUST SEND IT TO ATHLETICS WELFARE** having first made a copy of your disclosure or at least your disclosure number. Athletics Welfare will return it to you; a few weeks later your new license will appear in the post. If after issue you do not receive your disclosure in the post from the DBS you can, up to 91 days from issue, obtain a replacement by contacting the DBS on 0870 90 90 11

If you have any problems contact Mike Heffernan and I will try to help resolve them.

## Endurance

The County is now getting short of qualified endurance officials who are willing to volunteer to help at County Endurance Events. (The main one is the County Cross Country Championship) The tasks are really quite simple and are similar to the tasks carried out at a Track meeting, Line Judges, Funnel Judges & Funnel Recorders, Time-keepers and Time-keepers Recorders, Rope Marshalls etc. Anyone can qualify and again the grades are the same as for Track & Field 2a Club, 2b County, and 2c Regional. Also we are short of Race Adjudicators; these are officials who check that the UKA Event Standards are up held in races and are in line with UKA rules. Anyone interested in qualifying should initially contact Ernie Cripps, Barry Parker or Mike Heffernan; Courses can be arranged before the start of the next Endurance season in October.
